Should there not be enough alternates to fill the remaining statewide seats, a new nominations window will be opened. If an electoral seat becomes vacant, any statewide delegates from that unit will be used to fill that seat first; if none are available, then the electoral unit seats will be filled by alternates in order of highest vote total received.
